A Public Hearing for the Preliminary Budget of 2019 was held by the Town Board of the Town of Brighton on Thursday, October 25, 2017, at 6:00 p.m. at the Brighton Town Hall, 12 County Road 31, Paul Smiths, NY, with the following:

PUBLIC HEARING:

Supervisor Peter Shrope opened the Public Hearing for public comments on the Preliminary Town Budget for 2019 at 6:01pm.

Osgood Pond property owners had a Memorandum of Understanding (MOU) for a Lake Steward position for the Board to approve.

Supervisor Peter Shrope said they had to come to a Town Board meeting to discuss a MOU, as this was a Public Hearing for public input on the Budget for 2019. He said the next Board meeting is scheduled for November 8. He explained that the budget included a line for an appropriation under Parks and Recreation A7140.1 of \$7,000 and a revenue line for \$7,000 for Gifts and Donations A2705 to off set it. He said he also had a letter from the Rainbow Lake Association (RLA) concerning a "Lake Steward" so to be fair he doubled the amount the Osgood Pond Association said they would donate for a "Lake Steward" position.

Discussion was held on why this was a good idea to add funds to the budget for a "Lake Steward" position for more than one lake.

There being no further comments from the public, the public hearing was declared closed at 6:14 p.m.
