This sign was placed there in 2002 following the passage of Brighton Town Resolution #75, adopted 9/13/2001. Since the State requirement specifies that the sign face the water, the original sign was two-sided.

c. Letter from the Saranac Lake Volunteer Fire Department: Received a copy of a letter dated January 10, 2007 addressed to NYS legislatures from the Saranac Lake Volunteer Fire Department (SLVFD). The SLVFD would like support from the Town for changing the NYS General Municipal Law to allow a fire department based ambulance service to bill for rescue calls.

The letter was read for the record as follows:

"NYS Senator Betty Little, NYS Assemblywoman Theresa Sayward, NYS Assemblywoman Janet Dupery.

The Saranac Lake Volunteer Fire Department is currently a Village controlled Fire Department in the Village of Saranac Lake. We are a partly paid mostly volunteer organization that provides fire and rescue services to the Village of Saranac Lake. Our ambulances are certified to operate up to the paramedic level of care.

Currently five surrounding townships contract with the Village of Saranac Lake to provide fire and/or rescue protection to their townships. As expenses are rapidly escalating to operate our department, the latest contract negotiations between the Village and the towns have become very heated to say the least. All Townships have requested that our department start billing for ambulance services in order to lower costs. Presently in order to bill for services we would have to separate the rescue and ambulances from the Fire Department. General Municipal Law Section 209-b (4) prohibits us as a fire department based ambulance service from billing for services.

We feel that staying with the Fire Department, but being able to bill for our ambulance service is a vital issue to ease the burden on our surrounding contracted townships and to help us continue the level of care that we provide.

We understand that there has been discussion of changing the state wide Legislation that would allow fire department based ambulances to bill for services. At this time on behalf of the Saranac Lake Fire Department, we ask for any and all support that you can give to help in the speedy creation and the adoption of this Legislation. If there is not enough support to enact this state wide would you please give support for changing it for at least Franklin, Essex, and Clinton Counties.

#### 4. TAX COLLECTOR - Amber Mckernan

- a. Received notice that the tax roll and warrant for tax season 2007 were available for pickup at the Office of Real Property in Malone on Thursday, December 28 after 11 a.m. Tax bills were prepared for mailing and sent out by 10:30 a.m. on Saturday, December 30. Carried local bills to each of the three post offices in Brighton and posted a public notice of receipt of the warrant in those post offices, as well as one on the Town Clerk's Sign Board outside the Town Hall and one inside the Town Hall. Faxed a copy of the public notice to the Adirondack Daily Enterprise with a request that the notice be published once a week for two consecutive weeks.
- b. Received the tax roll data onto the computer from BAS, the tax collector's software provider, via a download from the internet on December 29
- c. The amount of the Warrant for 2007 is \$1,500,111.03, which is a decrease from last year's warrant in the amount of \$89,970.07 over 2006. The amount to be paid to the Town of Brighton Supervisor is \$542,588.00, an increase in the amount of \$12,095.00. The amount to be paid to the Franklin County Treasurer for 2007 is \$957,523.03, which is a decrease of \$102,785.03 from 2006. Received notification of an adjustment to the warrant in the amount of \$.48 to be subtracted from the warrant. The new total for the warrant is now \$1,500,110.55.
- d. Received approximately 30 phone calls and five e-mails and sent 6 faxes regarding tax matters
- e. To date have collected \$173,879.12 with 131 posting (14% collected). During December 2006 collected \$5,794.90.

#### 5. TOWN JUSTICE (Nik Santagate): Report given by David Knapp

- a. Disposed of 33 cases and issued a check in the amount of \$1,880.00 to the Supervisor
- b. Received a copy of the Security Assessment from the NYS Unified Court System. Recommendations were noted as follows:
  - i. Page 5 Halogen Street lamps in employee parking lot and recessed lights at every entrance and exit Currently there is a light with a timer at the back entrance.

#### COMMITTEE REPORTS

#### 1. HIGHWAY DEPARTMENT - David Knapp and Steve Tucker

- a. Report from Superintendent Don Oliver read by David Knapp
  - i. Working hours as of January 2 are 4 a.m. to 12.30 p.m.
  - ii. Plowed and sanded road
  - iii. Performed routine maintenance of vehicles
- b. Other issues
  - i. White Pine Camp Road Bridge:
    - (1) Superintendent of Highways Don Oliver spoke with the Franklin County Highway Department at a meeting he attended on December 20 concerning cost of the box culvert on County Road 31. They paid \$148,000 for the work and \$24,200 for the engineering fee for a total of \$172,200.
    - (2) Supervisor Peter Martin received a phone call from the Franklin County engineer who said the Town may be able to just repair the bridge this year. There is no place to set up a temporary bridge due to the wet lands around the area if the bridge is to be replaced. There would be no access to the other side of the water.
    - (3) Sheila Delarm said the repair would be about \$5000 and last five to 10 years.
  - ii. Agreement for the Expenditure of Highway Moneys:

#### AUTHORIZATION TO EXPEND HIGHWAY FUNDS IN THE AMOUNT OF \$50,000 FOR IMPROVEMENTS OF HIGHWAYS

**RESOLVED**, that the Town Board agrees to provide the Superintendent of Highways the sum of \$50,000 to be expended for Permanent Improvements of town highways as follows:

First the Wardner Road leading to the end, for a distance of .25 miles, will be blacktopped 2 inches thick, 18 feet wide; then second, the Tebbutt Road commencing at the Vosburgh Road to the end, for a distance of about .65 miles, will be covered with dense binder 3 inches thick, 20 feet wide, not to exceed the \$50,000.

- iii. Sand for Paul Smith's College: Don Oliver asked for the Board to determine what the agreement is with Paul Smiths College for obtaining sand for their roads. The Town now owns the land where the sand is mined. The College is contracting for their snow removal and the contractor should not be getting the sand free from the Town. David Knapp will find out the volume of use.
- iv. Letterhead for Town Highway: Town Clerk will order a ream of paper from Currier Press with letterhead.
- v. Monthly Report: Received a copy of a Highway Monthly Report from the Town of Harrietstown. **Supervisor Peter Martin** said he spoke with the Highway Superintendent of the Town of Santa Clara,

he does not give a monthly report. He communicates with the Council members so they know what is going on. David Knapp said a letter will go out to all departments asking for the same information be provided by all departments and committees in a monthly report to the Town Board in according to the Organizational Meeting operating procedures.

- vi. Salt Shed Bids: There were no bids received for completing the salt shed. Bids will go out again in March. This information was added to the letter sent to Robert Tebbutt in response to his concern about the salt shed.
- vii. Overtime: Don Oliver is concerned with overtime because he moved the shift back. Supervisor Peter **Martin** said they could go to a split shift if needed. People are happy that the roads are cleared in the morning for the buses and people going to work. There was not a lot of overtime paid last year.
- Decals on Trucks: David Knapp has not been able to get in touch with Mr. Lemieux concerning the viii. design of the decals for the vehicles. He will continue to pursue this issue.
- ix. Town of Brighton Signs: Had a request from a residents about the Town sign on State Route 86 near Split Rock Road. The NYS DOT did not put the sign back up after paving the road. David Knapp will ask Don Oliver about the sign. He will ask Mr. Lemieux for a price on more signs.
- x. CSEA Contract: Lydia Wright said the language for the health insurance part needs to be changed before the contract is approved. The Attorney for the Town needs to provide the language, not the insurance company. Lydia Wright will contact the Attorney of the Town to review the contract.

#### 2. PARK & RECREATION - Steve Tucker and Lydia Wright

a. Lease of Park from Paul Smith's College: The liability insurance needs to be increased to 3 million dollars coverage. Sheila Delarm will contact NYMIR for more information on cost of increase.

David Knapp asked about number of people using the park. Steve Tucker said Dan Spencer was keeping track of it for a while. Steve Tucker said he has been at the Park a lot lately and there have been people there.

- b. Ice tarp was laid for skating rink. It is in bad shape from "wear and tear" but can still be used. The Paul Smiths-Gabriels Volunteer Fire Department (PSGVFD) put down some water for ice. The Highway Department bought dirt to hold the tarp and water in place.
- c. The new sump pump installed in the fall is not working well. It was traded-in for a working one that was cheaper, there is now a credit at Aubuchon's Hardware.

#### 3. INSURANCE - Sheila Delarm and Lydia Wright

- a. Certificates of Insurance are needed from NYMIR for Paul Smith's College, NYS Department of Transportation, and PSGVFD
- b. Lydia Wright will contact the Comptroller's Office for information on Tax Collector bond limits.
- c. Sheila Delarm is waiting for an answer from NYMIR for coverage of the Tax Collector's documents.
- d. COBRA Insurance was discontinued at the request of Robert Tebbutt; cancelled as of December 31; Christy Smith at Burnam needs a copy of cancellation.
- e. Renewal application for NYMIR insurance needs to be completed, Lydia Wright and Sheila Delarm will work on it.
- f. Zurich Insurance has sent a premium notice for disability insurance, four people are covered from Highway.
- g. Mang Insurance has sent a premium notice for bonding of officials.

#### 4. INVESTMENTS - Sheila Delarm and Lydia Wright

- a. CLASS interest has decreased a small amount to 4.9%.
- b. Supervisor Peter Martin attended the luncheon held by MBIA in December.

#### 5. CEMETERY - Steve Tucker and David Knapp: Nothing to Report

#### 6. TOWN BUILDINGS - Steve Tucker and David Knapp

- a. Town Hall: Trap on kitchen sink was repaired. A new smoke detector and fluorescent lights are needed .
- b. Town Hall Project: Contacted Crawford and Stearns for wording on bid proposals. Information from Town Garage Specification Book could not be used at is was very specific to the Garage Project. The Town does not have a "boiler plate" bid proposal because we do not do a lot of bid proposals. David Knapp will continue to work with Crawford and Stearns to complete the bid proposals.

#### **CITIZENS COMMENTS:**

Art Robinson: Commented on how other Towns are having to put controls on their Highway Department to keep them from overspending. He wanted to know about the Towns investments and the Town should invest the maximum allowed. Lydia Wright said the CLASS accounts are interest bearing. The NYS Comptroller's Office recommends a limit of 25% of the total budget that can be kept in reserve, right now the Town has more than 25% in reserve.

Art Robinson: He would like to see the Town go to arbitration on the rescue contract before they approve it. People should let the fire department and EMS volunteers know that they appreciate their services by donating to them. He thanked the Board for the great job they have been doing, he is glad to see the Town Board discussing items and working together.

#### **OLD BUSINESS**

- 1. **DISASTER PLAN:** Sheila Delarm said there is a meeting on Thursday, January 18, 2007at 6 p.m. for further discussion on the Disaster Plan. The Adirondack Medical Center will be sending a representative. Draft #2 has been distributed to the Board.
- 2. RESCUE CONTRACT: The Town Board attended another meeting with the other town boards to discuss changes to the rescue contract. Supervisor Peter Martin said the proposed numbers from the Village of Saranac Lake keep changing. He said there has been a lack of communication between several parties. He received an fax letter from the Health Department discussing the "Certificate of Need (CON)" issued to Saranac Lake Volunteer Fire Department (SLVFD), there cannot be a lapse in service while the contract is being negotiated. The Town Clerk said the "six-months" contract is the one put out for the public hearing. Steve Tucker said the contract for fire has to be for a minimum of one year, not longer than five years, and the dollar amount has to be in the contract. Supervisor Peter Martin said he talked to Mountain Lakes, the regional EMS council, who has agreed to issue an emergency CON if needed on January 26 to St Regis Falls and Tupper Lake ambulance services. This CON will be for sixty days. The CON for SLVFD covers the Saranac Lake Central School District which includes the Town of Brighton. David Knapp and Lydia Wright attended a Village of Saranac Lake board meeting. The Village offered another contract and will accept the amount each town put in their budgets for 2007. This contract offer is good until January 26 at noon for the towns who did not sign the contract on December 30. The counter-offer made by the towns, for last year's amount plus 20%, was not accepted by the Village board. Discussion was held on what other rescue services get for payments. Supervisor Peter Martin said Harrietstown and Santa Clara may not hold out because they need fire protection. Brighton may be on its own after January 26 because we only need rescue services. Lydia Wright asked if the Attorney for the Town has reviewed this contact. She was under the impression that the contract was drawn up by the Village Manager John Sweeney and not the Village's attorney. The contract has not been reviewed by Scott Goldie. Supervisor Peter Martin said he received a call from Franklin County Legislature Gordy Crossman. He is concerned about the rescue contract negotiations, he got a call from the Franklin County EMS. The current contract received from the Village has not been signed by the Mayor. There is no increase
